



## **INVITATION FOR GALLERIES TO TAKE PART IN:**

**contemporary art ruhr (C.A.R.) 2019, the innovative art fair, October 25-27, 2019, World Heritage Site Zollverein, exhibition halls: A 2, A 5, A 6, A 9, A 12, Essen, Germany**  
**- Closing date for participants: July 15, 2019, post stamp -**

### **I. The Aim**

contemporary art ruhr (C.A.R.), the innovative contemporary art fair, takes place within an excellent industrial architecture, the World Heritage Site Zollverein, located in Essen. C.A.R. consists of two annual art fairs that have been taking place in several halls at Essen's Zollverein World Cultural Heritage Site since 2006: the more PHOTO/MEDIA ART FAIR in spring and the innovative fair for contemporary art in autumn.

- **The location:** The World Heritage Site Zollverein, with its unique architecture, located in Essen. Formerly the world's largest coal mine, Zollverein is also known as "the most beautiful coal mine". designed in New Sobriety style, it is regarded as one of the most impressive monuments of the industrial age and is now a centre of the Ruhr metropolis's creative industry.
- **The concept:** With an open exhibition space art and communication will be the focus; communication barriers between participants and visitors are disappearing.
- **The participants:** with a choice of exhibitors that make perceptible blend of innovation and quality within their conception.
- **The support:** with high quality – and the option of individual and uniting all interested galleries of contemporary art, renowned art projects and institutions as well as young artists selected by a jury.

### **II. The Conception**

In an open space exhibition situation galleries present their program. Instead of the usual art fair scenario we want to create in general an aesthetic atmosphere, which shall put the peculiarity and the special offer of your gallery into focus, bound into an exclusive overall-view. We offer a modular exhibition-system especially created for galleries' presentation. In order to ensure a sort of puristic and minimalist exhibition-aesthetic, we exclude, unless otherwise agreed, all other exhibition and fair-furnishings.

### **In the field of the innovative art fair we offer various exhibition areas:**

**Hall 2:** special exhibition (500 sqm)

**Hall 5:** exhibition hall for galleries (1000 sqm)

**Hall 6:** exhibition hall für galleries, special areas (300 sqm)

**Hall 9:** exhibition hall für galleries, special areas (700 sqm)

**Hall 12, upper floor:** special exhibitions, limited areas for particular themes or artists to support (1100 sqm)

**Hall 12, ground floor:** special areas and exhibition (300 sqm)

As well as the outside area of Zollverein

### **III. Dates**

**Setting up:** Thursday, October 24, 2019, starting at 3 to 6 pm; or Friday, October 25, from 10 am to 3 pm

**Opening:** Friday, October, 25, 2019, 8 pm, V.I.P. preview, 6 pm

**Main fair days:** Saturday, October 26, 2019, 12 am to 8 pm, and Sunday, October 27, 2019, from 11 am - to 7 pm

**Dismantling:** Sunday, October 27, 2019, starting at 7 pm – 11 pm

### **IV. Different variants of presentation & participation fee (plus 19 % value added tax):**

**We offer the following variants of presentation, which will be determined by the management according the option and availability:**

#### **1. Basic booth and gallery space**

**Hall 5, hall 6, hall 9, hall 12:** with an area of circa 16 metres square size à EUR 1200,-, **1 wall system is inclusive**, which is in the center of the area, wall system: 2,15 m high x 2,40 m broad, existing of 4 parts

(each is 1,20 m broad x 2,15 m high), wooden, white, which are fixed by an angle of 90 degree, with a wall running metres of circa 9,5 m.

***Please inform us, if you are interested in alternative variants, e.g. to rent two or more basic booths.***

## **2. Larger booth and gallery space**

**hall 5, hall 6, hall 9, hall 12** with an area of circa 25 metres square size à EUR 2000,-, **2 wall systems**, which are in the center of the area, are inclusive (combined as U or L), with a wall running metres of circa 19 m.

## **3. Individual fair berths**

Only in hall 5: At the head wall are 3 individual fair berths. Please, inform us if you are interested.

## **4. Exclusive booths**

**hall 5, hall 6, hall 9, hall 12** with an area of circa 32 metres square size à EUR 3000,-, **3 wall systems** which are in the center of the area, are inclusive, with a wall running metres of circa 26 m.

**5. Sculpture position (only in connection with a gallery booth):** As a special offer we suggest every participating gallery the option to take part with a sculpture position in the sculpture area of the exhibition halls with a sculpture area of circa 16 metres square size or in the outside area for a fee for use à 1000,- EUR. *Please note it in your application!*

**6. Optionally, every participating gallery can take part by 1 contribution in the C.A.R. Video Lounge for a fee for use à 100,- EUR. Please note it in your application!**

### **The fee includes also:**

- two chairs or stools are inclusive
- light: the halls are generally illuminated
- wall systems: may have signs of use
- electricity: we offer special zones, which are not guarded, where it is possible to load e.g. a laptop. We agree the individual requirement before. We raise according to the individual need a ready position flat rate.

### **as well as communication services:**

- presentation in the exhibition catalogue and on the website; further on professional PR Campaign, press relations and publicity-activities, social media

each exhibitor receives 6 VIP-cards, 40 Vernissage cards, flyers and posters, up to 4 exhibitor-passes and 2 exhibitor catalogues (printed or digital version); standard labeling of your gallery booth inclusive.

## **V. Your Presentation**

\* the completely filled out registration

\* a short description of your gallery including additional information about the artists: CV of each exhibiting artist, list of exhibitions, photo-material of the artists and their art works which shall be exhibited (title, year, format, number of copies published if applicable; gallery-price)

\* a short information about how you want to present yourself, and if wanted, an additional list of all objects, artefacts and material which are part of your presentation.

You can send these information both per mail or email: mail@contemporaryarttruhr.de. Please use exclusively the standard formats (doc; txt; rtf; pdf; tiff; jpg, 300 dpi). In case of films please send only DVD, CD-ROM with maximal 30 minutes running time. The competitor bears the costs for submission. If you want us to send back your documents, please insert an addressed, stamped envelope or package.

## **VI. Conditions of Participation**

Every professional, innovative and ambitious gallery is invited to take part. The number of exhibition-space however is limited and will be determined by the management. The organizer reserves the right to change the conditions of participations at any time.

### **Criteria**

- \* provable professionalism

- \* quality of art work
- \* clear main points of emphasis on contemporary art
- \* innovative gallery-conception

At application a fee of EUR 360,00 is to be paid (Sparkasse Essen, account no.: 0003602109, Bank code no.: 36050105 IBAN: DE31 3605 0105 0003 6021 09, BIC: SPESDE3EXXX, galerie/agentur 162, concerning: contemporary art ruhr 2019 (C.A.R.), innovative art fair). This fee will be paid back in case of non-confirmation by the organizer. In case of confirmation this fee will be settled as deposit on the participation fee. This fee will not be paid back in case of withdrawal of the participant. You will receive an invoice attached to your booking confirmation which has to be paid, minus the deposit, 15 days after receipt.

At registration the participant acknowledges these conditions and gives permission to publish pictures, photos, information in the internet, publications and other media free of charge. The exhibitor transfers all copyrights of all the transferred motives for publicity and guarantees ownership (copyright, use of names, trademark). The organizer is not liable for any damages or loss of photographs and documents. We of course grant to handle all submissions carefully.

### **VII. Selection**

The application, inclusive the properly filled out, legally binding signed registration and submitted on schedule, does not justify any claim to participation. A circle of independent advisers and curators, being determined by the management, will decide about participation. This decision will not be contestable, there can be no recourse to litigation. On the basis of all applications the management will design the general conception of the art fair and hand out the areas and booths. Exhibitors' claim on a particular area or booth is impossible. The organizer reserves the right of short-term changes concerning exhibition-areas. The contract between management and participants will come into being by confirmation and tendering of account. Products, exhibitors and persons that are not being mentioned in the application documents are not allowed to take part without written permission. All acoustic and visual performances have to be settled between organizers and exhibitors.

### **VIII. Insurance**

The organizer will not take out insurance concerning the exhibition area and the booth of a gallery as well as the exhibition of sculptures in the outside area. Security personnel however will be at disposal. Further on we assure highest care concerning entrance-control of the visitors. Yet control and guarding of exhibition areas and the booth of a gallery as well as the outside area for sculptures are not included. The exhibitors are liable for all damages that might occur to exhibition-objects by setting up, by operations, by performance, by employees and colleagues of the exhibitor. If wished for, we can deliver you the contact to our insurance agent.

### **VIII. Acts of god**

In case of acts god or any other legitimate and compulsory reason, the organizers are entitled to postpone or cancel the event. In such a case there is no claim for damages for exhibitors. Exhibitors who act in contrary to the fair's regulation may be excluded by the management. Exhibitors bear full liability.
